As such he advocated in favour of nationalization of land and the leasing out of land to small groups of cultivators. He also realized the necessity of industrialization so that the surplus labour from agriculture could be moved to other productive livelihoods. He played a very important and constructive role. 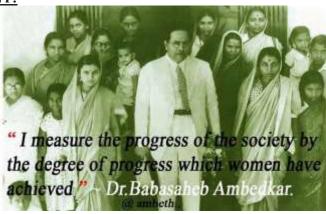

Ambedkar leader ship.

As a member of the Bombay Legislative Assembly. Ambedkar gave effective expression to the grievances of the rural poor through his mass movements. His successful struggle against the prevailing land tenure system called Khoti liberated a vast majority the rural poor from an extreme form of economic exploitation. His successful agitation against Mahar Vatan emancipated a large section of the rural poor from virtual serfdom or feudal victim. He presented a bill in the State Assembly aimed at preventing the malpractices of money lenders hurting the poor. Dr. Ambedkar founded in 1936, the Independent Labour Party. While the prevailing trade unions fought for the rights of workers they were indifferent to the rights of untouchable workers as human beings. The new political party took up their cause. Subsequently, as a Labour Member of the Viceroy's Executive Council from 1942 to 1946, Dr. Ambedkar was instrumental in bringing about several labour reforms including establishment of employment exchanges (still it is running), generally laying the foundations Industrial relations in Independent India. His ministry also included irrigation, power and other public works. He played an important role in shaping the irrigation policies. The Damodar Valley Project is one of the best examples of his work and devotion.

Ambedkar's perception of women question; emphasizing their rights to education, equal treatment with men, right to property and involvement in political process resembled the global feminist demand. Dr. Babasaheb Ambedkars contribution to economic development and progress of women is significant According to him, participation of women in the economic development is impossible without developing their social status and equality. But due to bad economic conditions of women in India, India's economic progress is hampered. So, it is important to improve the economic condition of women and give those equal rights and freedom of occupation. He provided several provisions in the constitution for protecting the welfare and civil rights women. Protection of women rights he advocated the Hindu code bill in the parliament he also concerned the religious conversions and legal rights for Muslim women.

7. SOCIAL JUSTICE:

Dr. Ambedkar was very adherent to social justice in nation and society. His concept of social justice generated from the French revolution in 1789. Ambedkar's perspective of social justice is based on social democracy which consists of three concepts of justice, namely liberty, equality, and fraternity. These principles of liberty, equality and fraternity are not to be treated as separated items in a trinity. They form a union of trinity in the sense that to divorce one from the other is to defeat the very purpose of democracy? These principles are fundamental rocks of Just Society Order and were origin from France revolution. Raphael admits justice and liberty are the two basic ideas of all political thought. Every society needs some sort of concept concerning that structure. Justice is the basic concept of social values; it is what holds a society together? His concept of liberty is a fundamentalism among political and philosophy thought. According to Ambedkar, liberty has divided into two categories namely Civil Liberty and Political Liberty. Ambedkar's notions of civil liberty deals with three basic opinions are; Liberty of movement, Liberty of speech and Liberty of action. Civil liberties are often formally guaranteed in Indian constitution but ignored in practice which came from Bill of Rights. Civil right is often used to refer to one or more of these liberties or indirectly to the obligation of government to protect dalits from violations of one or more of their civil liberties.

8. DR.B.R.AMBADKARS -PUBLIC FINANCE:

The thoughts of Dr. Ambedkar on Public Finance can be studied in his M.Sc Thesis "The evaluation of Provincial Finance in British India", from the discussion of article 227 and 277 of the Indian constitution; the taxation policy in the manifesto of Swatantra Majdur Paksha and his lectures and views on budgetary policy and property tax. He has classified provincial finance in three categories imperialistic provincial finance provincial and local critising the Decentralization Report of the Royal Commission, Dr. Ambedkar argued that due to the provincial autonomy political power would be concentrated, in the hands of the privileged few instead of common people. Dr. Ambedkar PhD Dissertation represents a major contribution to the history of Indian Public finance. In this thesis he elaborates centre-provincial relationship from 1833 to 1921. He provides a detailed and insightful historical perspective and shows how Centralization of government finance was a failure due to faculty fiscal system. The Contemporary relevance of Dr. Ambedkar's contribution to public finance is that first of all it is a pioneering work. According to Seligman his guide and world famous economist" it is objective recitation of facts and impartial analysis of the centre state relationship in British India". It has a great historical significance. Second and more importantly it provides groundwork for centre state relationship in modern India. It has been the guiding spirit behind the Reports of the successive Finance commissions in Independent India. The credit for establishment of the Finance commission and the R.B.I. goes to Dr. Ambedkar's views.

9. DR. AMBADKAR – ECONOMIC DEVELOPMENT:

Dr. Ambedkar believed that the strategy for India's Economic development should be based on: Eradication of property elimination of inequities and ending exploitation of masses. He accepted Marxian view in this respect. Yet did not favour the Marxian the Indian Context social or of development. Dr. Ambedkar views on communism are presented in his essay "Buddhism and communism" Unlike Marx he did not accept economic relationship as the be-all and end-all of human life. He emphasized expiation has many dimensions Infect in exploitation. Dr. Ambedkar rejected Violent and totalitarian direct ship methods of com religious exploitation is no less Oppressive than economic exploitation. Dr. Ambedkar rejected Violent and totalitarian direct ship methods of communism. He believed in a classless but not a stateless Society. He perceived an active but well defined role for state in Economic affairs. His concept of democratic state socialism is based on (a) State ownership of agriculture and key industries (b) Maintenance of productive resources by the state and (c) a just distribution of Common produce among different people without caste or creed.
